


Passage 3

The attack on two oil tankers in the Gulf of Oman, which connects the Arabian Sea with the Strait of Hormuz, a critical choke-point in one the world's busiest shipping routes, has raised tensions between the U.S. and Iran. The crisis has also pushed up global oil prices as well as the cost of shipping insurance. Within hours of Thursday's attack on the vessels, one is Japanese-owned and the other Norwegian, the U.S. has blamed Iran for the incident. The U.S. Central Command, which is based in the Gulf, has also released a video footage that the U.S. claimed showed men on an Iranian boat removing a mine from one of the tankers.

This was the second time in two months oil tankers have come under attack in the region. On May 12, four vessels, owned by Saudi Arabia and Norway, were targeted off the UAE coast, just outside the Strait of Hormuz. The U.S. had blamed Iran for that attack as well. Tehran has denied any role in the incidents. Whoever is responsible for these attacks, they are actually weaponising the Strait of Hormuz and the Gulf of Oman, both vital spots on the Gulf-Arabian Sea trade route.

Passage 4

- The NITI Aayog on Thursday released the results of a study warning that India is facing its 'worst' water crisis in history and that demand for potable water will outstrip supply by 2030 if steps are not taken.
- Nearly 600 million Indians faced high to extreme water stress and about 2,00,000 people died every year due to inadequate access to safe water. Twenty-one cities, including Delhi, Bengaluru, Chennai and Hyderabad will run out of groundwater by 2020, affecting 100 million people, the study noted. If matters are to continue, there will be a 6% loss in the country's Gross Domestic Product (GDP) by 2050, the report says.
- Moreover, critical groundwater resources, which accounted for 40% of India's water supply, are being depleted at "unsustainable" rates and up to 70% of India's water supply is "contaminated," the report says.
- Envisioned as an annual exercise, the ___A__, to evaluate States, has been developed by the NITI Aayog and comprises 9 broad sectors with 28 different indicators covering various aspects of groundwater, restoration of water bodies, irrigation, farm practices, drinking water, policy and governance. "While Jharkhand and Rajasthan may have scored low, they have made remarkable improvement when compared over two years," said Amitabh Kant, CEO, NITI Aayog.
- Other experts said that unless India woke up to its water crisis, disaster loomed. "There is great awareness now about air pollution, however, India's water crisis does not get that kind of attention," said Rajiv Kumar, Vice-Chairman, NITI Aayog.

Passage 5

- Today, India is host to over 200,000 refugees like her who have been forced to flee conflict and persecution in their home countries. On World Refugee Day, there is a need to reassess India's approach to refugee protection, particularly in light of the regional refugee crisis after the mass exodus of the __A__ from Myanmar.
- Traditionally, India has hosted several persecuted groups such as Tibetans and Sri Lankans. While it is not a signatory to the 1951 Refugee Convention and has no domestic asylum law, it has reiterated its commitment towards the protection of refugees at various international fora, including the UN General Assembly.
- One of the most significant affirmations of this commitment was demonstrated by India becoming a signatory to the New York Declaration for Refugees and Migrants, which was adopted by 193 countries in September 2016. In doing so, India has expressed its solidarity with those forced to flee and agreed that protecting refugees and supporting the countries that shelter them are shared international responsibilities that must be borne more equitably.
- The Declaration sets the stage for a new framework for refugee protection the Global Compact on Refugees (GCR).
- Although India has hosted refugees of varying nationalities for decades, the country has done little beyond providing asylum. There have been some attempts to introduce a refugee law in the country, the latest being the Asylum Bill 2015, introduced as a private member's bill by Shashi Tharoor. However, none has gone the distance and the government continues to adopt an ad hoc approach towards this group. Given that most refugees have been unable to return to their countries, leading to protracted refugee situations, there is an urgent need for the government to develop a uniform framework for their management during their stay in India.
